Girma, Essete (2019), highlighted that they main focus is to identify challenges and factors affecting performance of Custom Clearance Agent from delivery time interval. Quantitative data source were used and primary data is collected using questionnaire, interviews and data analysis through regression and descriptive statistics. They analysed that the challenges on CC is due to improper delivery of shipment which reduces performance and recommended that improvement towards CC process which minimizes delay and increases performance.
