The aforesaid examples hold water for substantiating the main argument in the essay. However, we need to remember that perceptions are always biased. Take these examples again. Taking the occurrence of Second World War from the perception of Hitler, would he perceive that Second World War was a necessary step for Germany's salvation? For Hitler, his action in domestic and foreign affairs may be appropriate whereas for the other political

Therefore, perceptions become different and there is a tendency of biasness to creep in. Nonetheless, the significance of timing holds critical in both the cases.

She might, for instance, argue that history and religion are subjective knowledge areas and therefore my argument would lose its strength in the context of the objective knowledge areas like natural sciences and math. However, to substantiate my claim, I would say that a vector addition formula may have remained unchanged with time but the advancement in technology over the ages has helped in solving complex problems easily.
