The collected data was passed through statistical analysis and regression was applied to identify the impact of calculating variables on the criterion variable which revealed that the test variables have profound impact on the criterion variables. Hence, it was concluded that the test variables have noteworthy relation and have important effects on each other.

The terrorism chiefly triggers the damage to entire set-ups, distracts the survival of entire people, interrupts the political stability and effect the social success of the whole country Muhammad & Khan, (2014).

The social and academic life of any area is greatly influenced by terrorism. The review of related research showed that there exists negative influence of terrorism upon the social and academic standard of the area and the entire country on the whole. During the last era, an increase in terrorist activities seems to greatly influence the educational organizations in the entire area Ahmad, Masood, Dean, Shakir, Kardar & Barlass (2011). The only criterion for the educational standards is peace and success which are hugely influenced by terrorism. The terroristic activities were also brought out against educational staff especially teaching staff, learners, educational institutions and collectively the supporting staff, educational officials and trade unionist Munir,(2015). The terroristic attacks collectively distract the school buildings, setups, violent attacks on buses carrying schools children which chiefly affected the educational events in the whole area Jamal, Khan and Muhammad, (2016). This research paper intended to highlight the role of terrorism on the socio academic students of the north and South Waziristan Khyber Pakhtunkhwa Pakistan.

Presently, most the sectors have lost their potentiality and dynamic functioning due to the war against terrorism because it not only affects the even working of these sectors but also enhances their expenses on security and precautionary measures Muhammad, (2016).

Government of Pakistan has started military operations against the terrorists on vast range. Various army and civil personnel were injured and martyred as the result of these operations. Incidentally, the terrorism is a national risk which required particular commitments on the part of government to uproot the cause of terrorism in the region Haider, Heredero, Ahmad & Sumaira, (2016).


For this purpose 344 questionnaires were distributed among the students of various schools, colleges out of which 310 were collected back from the participants with a response rate of 90%.

Graph 1 Graphical representation of Gender




The table and graphical representation showed that out of total 310 students, 246 were male and 64 were female students. Thus, the male students' ratio is higher than female students in the present research paper.
